# Terms and Conditions

*Bookings are subject to these terms and conditions:*

- The client's dog(s) will be collected from their home and walked for the specified time on the agreed days. For group walkies, Holmfirth Dog Walker may walk other dogs at the same time, but the total number of dogs walked with one person at one time will not exceed four.
- The client will usually be required to give Holmfirth Dog Walker a key to their home – purely for the use of collecting and returning the client's dog(s). This key will be used for no other purpose, will be kept safe and returned to the customer on demand.
- Where a dog flap is fitted, it is the client's sole responsibility to ensure that the garden and its fences are secure. It is not Holmfirth Dog Walker's responsibility to check this before leaving your dog following a walk.
- All dogs must be parasite free prior to walking. The client must also disclose any medical conditions that may affect their dog's health.
- The client is required to complete fully and honestly the Dog Information form and agree to these Terms and Conditions. Holmfirth Dog Walker must be alerted to any behavioural problems with their dog(s) at the time of booking.
- The client further agrees to notify Holmfirth Dog Walker of any unwelcome, aggressive, procreative or dangerous behaviour of their dog(s) that have potential to cause harm to any other pet or individual.
- Holmfirth Dog Walker will inform the client of any incident or anything which Holmfirth Dog Walker notices about the dog, which the owner ought to know. Holmfirth Dog Walker will take care, so far as is practicable, that the dog is not a nuisance or danger to any one, or any other animals, and that no harm comes to it.
- The client understands that whilst their dog is walking with Holmfirth Dog Walker, they may be walked with other clients' dogs which Holmfirth Dog Walker will have assessed in terms of behaviour and temperament. The client further understands that during normal dog play, their dog may sustain injuries. All dog play is carefully monitored at Holmfirth Dog Walker to avoid injury, but scratches, punctures, torn ligaments, or other injuries may occur despite the best supervision. The client understands they are responsible for the medical treatment of any injuries or illness that their dog receives whilst under the care of Holmfirth Dog Walker and agree to pay all vet care and costs that may arise due to the injury or illness.
- The client understands that should their dog attack/be involved in a dog fight with another dog/person, causing injury to that dog/person, the client is responsible for any losses incurred as a result including (but not limited to) payment of vet fees in respect of injuries to another animal caused by the client's dog.
- The client agrees to Holmfirth Dog Walker making decisions regarding my dog's health providing they are acting in the best interests of my dog; that they have made every attempt to contact the client or the Emergency Contact person first and that it is on the advice of a qualified veterinary surgeon. Vet bills that my dog may incur will be met by myself on my return.
